## **Invitation to Bid for**

### ***Construction of 2 Classroom School Building – Cogon National High School (Leonardo Canillo) Talicud Island under PR# 2021-06-2432***

1. The ***Local Government Unit of Island Garden City of Samal*** through the ***Special Education Fund*** intends to apply the sum of ***Two Million Seven Hundred Sixty Five Thousand Six Hundred Pesos and Sixty Five Centavos (PhP 2,765,600.65)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Construction of 2 Classroom School Building – Cogon National High School (Leonardo Canillo) Talicud Island under PR# 2021-06-2432***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
  2. The ***Local Government Unit of Island Garden City of Samal*** now invites bids for the above Procurement Project. Completion of the Works is required ***One Hundred Twenty (120) Calendar Days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
  3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  4. Interested bidders may obtain further information from ***Local Government Unit of Island Garden City of Samal*** and inspect the Bidding Documents at the address given below from ***9:00AM-5:00PM***.
  5. A complete set of Bidding Documents may be acquired by interested bidders on ***July 23, 2021*** from given address and website/s below {*Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PhP5, 000.00)*}. The Procuring Entity shall allow the bidder to present its proof of payment for the fees [***presented in person.***]
  6. The ***Local Government Unit of Island Garden City of Samal*** will hold a Pre-Bid Conference<sup>1</sup> on ***July 30, 2021 1 o'clock in the afternoon*** at ***BAC Conference Room, BAC Office, New City Hall Compound, Peñaplata, IGaCoS*** and/or through videoconferencing/webcasting which shall be open to prospective bidders.
  7. Bids must be duly received by the BAC Secretariat through ***manual submission at the office address as indicated below*** on or before ***12 noon of August 12, 2021***. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **August 12, 2021 1 o'clock in the afternoon** at **BAC Conference Room, BAC Office, New City Hall Compound, Peñaplata, IGaCoS** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
