## INVITATION TO BID FOR

### ***Purchase of ICT Equipment for Development of Functional Facilities and Amenities under PR No. 2021-06-2427***

1. The ***Local Government Unit of the Island Garden City of Samal***, through the ***General Fund 2021*** intends to apply the sum of ***Nine Hundred Thousand Pesos (₱900,000.00)*** being the ABC to payments under the contract for ***Purchase of ICT Equipment for Development of Functional Facilities and Amenities under PR No. 2021-06-2427***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
  2. The ***Local Government Unit of the Island Garden City of Samal*** now invites bids for the ***Purchase of ICT Equipment for Development of Functional Facilities and Amenities under PR No. 2021-06-2427***. Delivery of the Goods is required by *[insert the required initial delivery date or expected contract duration]*. Bidders should have completed, within ***Thirty (30) Calendar Days*** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
  3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
    - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
  4. Prospective Bidders may obtain further information from ***BAC Secretariat, BAC Office, New City Hall Compound, Peñaplata, IGaCoS*** and inspect the Bidding Documents at the address given below during ***9:00 AM - 5:00PM***.
  5. A complete set of Bidding Documents may be acquired by interested Bidders on ***July 23, 2021*** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P1, 000.00)*.
  6. The ***Local Government Unit of the Island Garden City of Samal*** will hold a Pre-Bid Conference<sup>1</sup> on ***July 30, 2021*** at ***1:00PM*** at ***BAC Conference Room, BAC Office, New City Hall Compound, Peñaplata, IGaCoS***, which shall be open to prospective bidders.
  7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before ***12:00 noon of August 12, 2021***. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **August 12, 2021 at 1 o'clock in the afternoon** at **BAC Conference Room, BAC Office, New City Hall Compound, Peñaplata, IGaCoS**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Local Government Unit of the Island Garden City of Samal** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
