**EXECUTIVE ORDER NO. 221**

**AN ORDER DIRECTING FOR THE TEMPORARY IMPOUNDMENT OF UNREGISTERED MOTORBOATS OPERATING IN THE ISLAND GARDEN CITY OF SAMAL**

**WHEREAS**, under Section 15, Article II of the Philippine Constitution, it is the State's Policy to protect and promote the right to health of the people;

**WHEREAS**, Proclamation No. 922, s. 2020, was issued declaring a State of Public Health Emergency throughout the Philippines due to Corona Virus Disease 2019 (COVID-19), enjoining all government agencies and Local Government Units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the threat of COVID-19);

**WHEREAS**, Presidential Proclamation No. 929 was issued Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019;

**WHEREAS**, pursuant to Section 16 of the Local Government Code, the City Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the city government for the promotion of the general welfare;

**NOW THEREFORE**, I, **AL DAVID T. UY**, City Mayor of the Island Garden City of Samal, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. DEFINITION OF TERMS:**

- a. **MOTORBOAT:** Refers to all motorized bancas regardless of weight, yacht and other recreational sea craft;
- b. **IMPOUNDMENT:** Refers to the seizure of boats by authorities;
- c. **AUTHORITIES:** Refer to the members of PNP, PCG, TF Samal, Bantay Dagat and other persons authorized by the COVID-19 SAMAL IATF;

**SECTION 2. MOTORBOATS.** All unregistered motorboats operating within the municipal waters of the Island Garden City of Samal shall be impounded by the authorities;


**SECTION 3. OPERATORS.** All operators of impounded motorboats shall be arrested for violation of existing laws;

**SECTION 4. VIOLATION.** Impounded motorboats shall be penalized with an administrative fine of Two Thousand Pesos (P2,000.00) per City Ordinance 2018-292 and other pertinent laws;

**SECTION 5. REPEALING CLAUSE.** All executive issuances inconsistent herewith are hereby repealed or modified accordingly.

**SECTION 6. EFFECTIVITY.** This executive order shall take effect immediately.
