EXECUTIVE ORDER NO. 249 Series of 2020

AN ORDER EXTENDING THE DECLARATION OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE ISLAND GARDEN CITY OF SAMAL

WHEREAS, the World Health Organization (WHO) declared the spread of the Covid19 virus infection as pandemic. This prompted President Rodrigo R. Duterte to issue Presidential Proclamation 922 declaring a State of Public Health Emergency and a State of Calamity;

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code provides that within their respective territorial jurisdictions, local government units shall ensure and promote health and safety and preserve the comfort and convenience of their inhabitants;

WHEREAS, IATF Resolution No. 60-A, Series of 2020 placed under Modified General Community Quarantine (MGCQ) from August 1 to August 15, 2020 the entire Davao Region (Region XI) composing of Davao de Oro, Davao del Norte, Davao del Sur, Davao Occidental, Davao Oriental, and Davao City;

WHEREAS, pursuant to Section 1 of Executive Order No. 248, Series of 2020, in accordance with IATF No. 60-A, the Island Garden City of Samal was declared under Modified General Community Quarantine (MGCQ) from August 1 to August 15, 2020;

WHEREAS, on August 16, 2020, Malacañang informed the public that the majority of the country will be placed under the modified general community quarantine (MGCQ) from August 16 to 31 except for 15 areas that are still in stricter lockdown measures;

WHEREAS, there is a need to continually impose the MGCQ Guidelines for the safety and security of the Samaleños;

NOW THEREFORE, I, AL DAVID T. UY, City Mayor of the Island Garden City of Samal, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. MGCQ EXTENSION. The Modified General Community Quarantine (MGCQ) as declared under Executive Order No. 248 is hereby extended until **11:59 of August 31, 2020** unless sooner lifted.


SECTION 2. All policies and guidelines of the Modified General Community Quarantine (MGCQ) under Executive Order No. 217, Series of 2020 as amended, Executive Order 248, Series of 2020, and all other previous issuances shall remain in full force and effect.

SECTION 3. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. REPEALING CLAUSE. All orders or issuances which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately upon signing hereof.
