EXECUTIVE ORDER NO. 273

**“AN ORDER REITERATING EXECUTIVE ORDER NO. 269, SERIES OF 2020 AND EXTENDING THE GENERAL COMMUNITY QUARANTINE IN THE ISLAND GARDEN CITY OF SAMAL UNTIL JANUARY 31, 2021”**

**WHEREAS**, Coronavirus Disease (COVID-19), a global pandemic declared by World Health Organization, continues to be a serious public threat to the health, safety, security, and lives of the Filipino people posing a long-term adverse effects on the means of livelihood and severe disruption of the economic activities;

**WHEREAS**, the City Mayor issued Executive Order No. 269, Series of 2020 declaring the entire Island Garden City of Samal under a General Community Quarantine (GCQ) until January 04, 2021 in accordance with the Provincial Declaration of GCQ in the whole Province of Davao del Norte;

**WHEREAS**, as we welcome the year 2021, COVID-19 continues to spread and transmit locally resulting to the increase of the infected individuals in the city as well as in the Davao del Norte;

**WHEREAS**, to help mitigate and control the further spread of the virus, pending the acquisition of the vaccines, and the impending threat of new strain of the virus, it is vital to sustain anti-COVID-19 efforts and support the National government in the combat thereof;

**WHEREAS**, the Provincial Governor Edwin I. Jubahib issued Executive Order No. 71, Series of 2020 extending the General Community Quarantine of the entire Davao del Norte until January 31, 2021;

**WHEREAS**, pursuant to Executive Order No. 71, Series of 2020, and in support to the anti-COVID efforts of the Provincial and the National Government, there is a need to reiterate Executive Order 269, Series of 2020 and extend the General Community Quarantine (GCQ) in the city until January 31, 2021;

**NOW, THEREFORE, I, AL DAVID T. UY**, City Mayor of the Island Garden City of Samal, by virtue of the powers vested in me by law, do hereby order the following:

**Section 1. Extension of GCQ.** The Island Garden City of Samal shall remain under General Community Quarantine (GCQ) **UNTIL JANUARY 31, 2021.**

**Section 2. Policies and Guidelines.** During the extended General Community Quarantine (GCQ), policies and guidelines enumerated under Executive Order No. 269, Series of 2020 are hereby reiterated and reimposed.


**Section 3. Separability Clause.** If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**Section 4. Penalty Clause.** Any violations hereof shall be dealt with under our existing laws, ordinances, rules and regulations.

**Section 5. Repealing Clause.** All prior executive issuances inconsistent herewith are deemed repealed.

**Section 6. Effectivity.** This Executive Order shall take effect immediately upon signing of this Executive Order.
