City Ordinance No. 2013-218

"AN ORDINANCE AMENDING CITY ORDINANCE NO 2012-193, OTHERWISE KNOWN AS THE ORDINANCE APPROVING THE NAMING OF ROADS, STREETS, PUBLIC STRUCTURES AND PUBLIC PLACES OF BARANGAY TAMBO, BABAK DISTRICT, ISLAND GARDEN CITY OF SAMAL"

Be it ENACTED, by the Sangguniang Panlungsod of the Island Garden City of Samal in session assembled, that:

SECTION 1. RATIONALE. The Sangguniang Panlungsod of the Island Garden City of Samal enacted City Ordinance No. 2012-193, otherwise known as the ordinance approving the naming of roads, streets, public structures and public places of barangay Tambo, Babak District, Island Garden City of Samal. After its approval, the said ordinance was transmitted to the National Historical Institute (NHI) for consultation. In a letter dated May 31, 2012, the NHI rendered its recommendation requiring the streets named "Orchids Street", "Birds of Paradise Street" and "Cactus Street" to be revised to its Local or Filipino names. Pursuant to the recommendation of the NHI, and upon consultation with the concerned barangay, the Sangguniang Panlungsod of the Island Garden City of Samal hereby modify the streets and alleys of Barangay Tambo.

SECTION 2. NAMING OF STREETS. The streets of Barangay Tambo, Babak District shall bear the following names:

SECTION 4. REPEALING CLAUSE. Any Ordinance, or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 5. EFFECTIVITY. This ordinance shall take effect immediately after fifteen (15) days of its publication in the newspaper of local circulation or after posting for fifteen (15) days at least in three conspicuous places within the city.
